### **OBJECTIVE #1: Offer psychiatric and counseling services in Woodford County.**

### **BACKGROUND ON STRATEGY**

**Evidence Base:** According to the data secured from the Tazwood Wellness Center, there was a dramatic reduction in therapy services provided to Woodford County residents from 2009 to 2011 when a satellite facility of the Tazwood Wellness Center closed in Woodford County. Increasing and/or expanding access within a county will increase the number of residents either seeking and/or receiving mental health services.

**Evidence Base:** Psychiatric and counseling appointments are being offered through the Tazwood Wellness Center at the Woodford County Health Department in Eureka. Staff members are trained to assess individuals, but need continual training on resources available in the community in order to make referrals to those services.

# OBJECTIVE #1: Collect data on repeat visits for individuals with a behavioral health related diagnosis by December 2014 for AEH to create a baseline.

### **BACKGROUND ON STRATEGY**

**Evidence Base:** Currently, repeat visits data is collected on inpatients but not on patients seen in the emergency room. Developing a process to collect this information will prove to be beneficial and help identify the scope of the issue for behavioral health related diagnoses seen in the emergency room at AEH. This will help the hospital better understand how to engage with other community partners in addressing mental health issues in the community.

### **BACKGROUND ON STRATEGY**

**Evidence Base:** Mental Health First Aid USA is an international evidence-based program managed, operated and disseminated by the National Council for Behavioral Health, Maryland Department of Mental Health and Hygiene, and the Missouri Department of Mental Health. The program is based on a standard curriculum designed to educate the general public about mental health, recognize individuals with mental health problems, and provide skills students can use to help those who are having a mental health crisis access help.
